

RELEASE AND AUTHORIZATION

RELEASE AND INDEMNIFICATION:

Participant hereby forever releases and discharges Edudance, Classrooms in Motion, its officers, directors, instructors, volunteers, independent contractors, as well as any person, employee, subsidiary, affiliate, party, or business entity that is affiliated with, sponsors or organizes "The San Diego County School's Dancesport Championship" ("Event Organizers") from liability for the following: (1) loss or theft of articles left in Changing Rooms, the Ballroom, or Hotel Rooms; (2) injuries sustained by any participant or any other person attending this event and Participant acknowledges that (s)he attends this event at his/her own risk; (3) any liability or claims arising from the production, exhibition, transmission, distribution or use of commercial material authorized in this Agreement; and (4) any claims, demands, suits and actions which Participant ever had, now has, or may have based upon any agreements previously made or herein made. Participant shall defend, indemnify and hold Event Organizers harmless from and against any and all claims, demands, losses, suits and expenses relating to this Release and Authorization arising out of Participant's actions or negligence.

AUTHORIZATION FOR USE OF PARTICIPANT'S IMAGE FOR COMMERCIAL GAIN:

Participant hereby irrevocably grants to Edudance, Classrooms in Motion, the sole and exclusive right to use, refer to and reproduce programs by means of video tape recording or any other method of media reproduction, hereinafter referred to as "reproductions." Participant authorizes Event Organizers to edit and arrange the reproductions, using Participant's name, voice, likeness, acts, poses, appearances and utterances as part of and in connection with Edudance, Classrooms in Motion. Participant authorizes Event Organizers to exhibit, transmit, distribute, sell and use in any manner, any aspect of Participant's performance at the EduDance Dancesport Championship contained in a reproduction in any advertising, publicity, promotion, video tape or in any field and form of media, throughout the world without limitation. All copyrights created relating to reproductions in which Participant's name, likeness, image, voice, and/or performance is featured, shall be the sole and exclusive property of Event Organizers. Participant waives any right to copyright enforcement and protection regarding any reproduction which includes any aspect of Participant or Participant's performance.

RULES & REGULATIONS

- This Release and Authorization form must be completed and returned with all required signatures prior to the event.
- Parents will not be permitted in or around the line-up area.
- No changes will be made at the event
- All events will be run even if couples are late or not present, no event will be repeated.
- Children are expected to be on their best behavior while attending the competition. They are NOT permitted to run or play in the ballroom or the convention center in general.
- Any complaints about a child will result in the child being prohibited from dancing and evicted from the ballroom. No refunds will be made under these circumstances.
- The Organizers have determined the dress code as outlined on the "Dress Code Standard" page. This rule will be strictly enforced. Anyone not adhering to the dress code will not be allowed to dance, or will be disqualified if they dance and no refunds will be given for entry fees, tickets, etc.
- Due to the high volume of entries and administrative work, there are no refunds.
